- ✓ Set-up High Availability on SecureChange (SC-HA1 and SC-HA2)
- ✓ Set-up Distributed Architecture with a Distribution Server (DS) and Remote Collector (RC)
- ✓ Add a Checkpoint device
- ✓ Add a Cisco ASA device
- ✓ Verify Networking Connectivity with all devices
- ✓ Successfully import new Zones
- ✓ Set-up/ import a working Unified Security Policy (USP) Matrix
- ✓ Verify topology map and associated Path Analysis checks
- ✓ Set-up a workflow in SecureChange (*using SecureChange Access Request Flow Diagram*)
- ✓ Set-up a workflow in SecureChange (*create your own*)
